The Finance Department is requesting the direct deposit amount for payroll be increased from the current \$60,000 to \$100,000 to accommodate being fully staffed and the raises that will be in effect at the start of the new fiscal year. Trustee Holguin asked for some clarification as to why it wouldn't increase by \$20,000 like previous occasions, it was only last fiscal year that this was requested to be moved from \$40,000 to \$60,000. Trustee Silva would like to physically see what the amount is and requested that it be sent via email to the rest of the Board by the next meeting. Trustee Holguin was not comfortable approving that amount without the supporting documentation.

The first time this item was presented the amount totaled roughly \$23,000 but has increased since at the time of the purchase of Dos Lagos there was a failure to update the county records stating that it was sold to a tax-exempt entity. Trustee Holguin asked if the City has made any attempt to show the county that the City is in fact tax-exempt, the Finance Director explain that he and Ms. Hidalgo (HR/CPO) have made several calls, sent multiple emails and have made several visit to the county without much success. Both Trustee Holguin and Trustee Silva would like to avoid paying this amount, and request a last attempt be made to be placed on the County Commission agenda's to allow the

City to speak their part and dismiss this charge. Trustee Silva made a motion to request the City Manager to write a letter requesting this case be presented to the County Commission as the last plea for dismissal before the next meeting.

*City Clerk requested a 5-minute recess to clarify the next item to be presented, there was a miscommunication with the approval of the agenda order and the removal of items from the consent agenda.

a. Consideration and Action to approve the \$26,000 purchase of new AC units, *Presented by the* Public Works Director.

The Public Works Director is requesting the budget be approved to replace two AC units at the portables and fix the units at City Hall and the Police Department. The Public Works Director explained that he had reached out to several contractors and only one responded, which is the quote that is presented to the Board today. Trustee Holguin asked why this issue wasn't brought up when the portables were renovated, Mr. Roman explained this was not checked at that time due to the lack of power there. Trustee Holguin also requested a breakdown of the overall price, each new unit will total \$9,500 and the remainder will be used to repair the two at City Hall. Trustee Silva's concern is the lack of the three quotes that are usually required, he understands the urgency but expressed that regardless of that our policies and procedures should not be dismissed. He sought legal advice but unfortunately the City Attorney was not present.

MPT Flores: Thanked the City staff for the ribbon cutting and groundbreaking of the urgent care.


Trustee Barreras: NONE
