9. ITEMS FROM THE MAYOR AND TRUSTEES

<u>Trustee Gonzalez</u>: She would like the audit presented to the Board at the next regular meeting. The City's master plan should be re-done. Have all the vehicles in the police department been put to use? No extra cars? How much does it cost to get the cars "ready" and put them to official use? There are buses crossing to Crossett Trailer park, creating a road and creating a lot of dust. The City should establish regulations for trailer parks regarding pavement. Trustee Herrera commented on this; regulations are in the Land Use Ordinance but have not been enforced.

<u>MPT Ramos</u>: Question regarding lighting meeting with EP Electric, and also asking about speed bumps for certain rural areas of the City.

Trustee Gameros: Governing Body Policies and Procedures.

Trustee Herrera: None

Mayor Trujillo: She will meet with Fernando Ramirez (Fin. Director) on having the audit presented at the next meeting. The Steering Committee for the City met last week (03/09/2017) regarding the economic development for the City and it was agreed the next Public Hearing would take place 4/19/17 with a follow-up meeting for the Steering Committee on 04/20/17. As far as MPT Ramos' question regarding the lights, the balance in the budget for lighting is \$18,235.54; which will cover the cost of installing approximately 25-30 lights around the city. There will be "New Leader Integration" training for employees given by MPT Ramos. Trustee Gonzalez suggests only department heads receive this training, then relay it to their staff. Lastly, the City will host a Spring Festival on April 8th on the soccer fields; this is a fundraiser to help pay for lights and benches for the field; more information to come.
