7. PRESENTATION

- **a.** Police department recognition. *Presented by City Manager:* Respectfully requested that this presentation be pushback. Staff will present at the next meeting.
- b. Presentation of Dos Lagos property tax for the year 2020. Presented by Payroll/Procurement Clerk
- City Manager: Staff has been trying to understand what the city's true liability concerning the property taxes of the former golf course. This week, I was able to connect with Mr. Edelman, the attorney who helped us through the acquisition and the transfer of title. The tax year starts in January, which is when the liability is determined. An individual owned the property at the beginning of the year; therefore, the year was not exempt from taxes.
- Spencer Edelman: The wording of the administrative code is that the tax liability for the year is established based on the ownership as of January first. What you see on the settlement statement, through closing, was appropriately credited. But for the remainder of the year, as the code is written, it is not exempt. Unfortunately, as I mentioned to the city manager, our firm does a lot of ongoing work for the county, so we cannot take on that challenge.
- MPT Herrera: Why did it take so long to bring this to the board? Could you have reached out to the county clerk or taxation department to fix this?
- City Manager: Our procurement clerk has been in contact with them for months on this. It's not anything new.

a) ORDINANCE 2021- 003 FIRST READING

An ordinance amending CN Wire lease agreement. Presented by Mayor Trujillo

Consideration and Action to pass: November 4th, 2021

- Mayor: We have the attorney for CN Wire at city hall and Mr. Jerry Pacheco. They are here to explain why we need this ordinance amendment.
- Eduardo A. Duffy: An IRB statute relates to municipalities that allow cities to issue bonds or projects within their boundaries or 50 miles of their incorporated boundary. CN Wire's facility is located within 50 miles of the boundary.
- The City was authorized to act as an issuer for that deal. The IRB essentially provides a project company with property tax abatements and gross receipts and compensating tax abatements on assets that they purchase for the property. In this case, the authorized amount was \$100 million, which doesn't mean that the city put any money out or was liable for that in any way. It just means that the project company could spend up to \$100 million and take advantage of those gross receipts and compensating abatements for tax purposes, including purchases of those assets.
- What makes the structure very beneficial to the city, in this case, was that 50-mile rule that by issuing the IRBs, the city exempted county taxes and other taxes that then apply to that area for the company. The city didn't lose any tax revenue because the project was not located within the city limits. As stated in the deal, the company actually pays directly to the city and not to the county. This payment is in lieu of taxes.
- As part of that arrangement, the company estimated the number of jobs anticipated yearly at the facility. When the project closed, that number was 195. The IRB currently provides that if the company misses that number within 65 to 79%, there's a 10% property tax payment penalty to pay. Due to COVID, the 195 is no longer a realistic target for the company. Talking to the company, they thought a more realistic number would be 130. The amendment in front of you changes that target from 195 to 130. The company will still make payments in lieu of taxes to the city, as usual. That is not changing.

- City Clerk: P&Z authorized this ordinance, with the hours of operation following the hours for alcohol sales. MPT Herrera informed us that the BOT-approved draft did not reflect the P&Z-approved hours of the sale.
- The P&Z Minutes were approved much later after the ordinance had been passed by the board. The update made today reflects the New Mexico Regulation & Licensing Department's hours of alcohol sale.
- o Trustee Gameros: Trustee Gameros suggested that section 13.7 include a reference to section 13.1p.
- o Trustee Flores: Requested a copy of the NM regulation and licensing department hours.
- o MPT Herrera: It was recommended that municipalities treat the marijuana business as any other business.

9. ITEMS FROM THE CITY CLERK

• City Clerk: Elections are still being held and they are taking place in the municipal chambers. Staff discovered five old Ballot Boxes while transferring to new storage. Old ballot papers will be kept with the city clerk until their record retention term expires, according to county officials.

10. ITEMS FROM THE CITY MANAGER


• City Manager: The engineers would like to meet with the board for a special meeting to discuss two issues. The first is a project update on the South Anthony Arroyo. The second item on the agenda is to discuss the pending development agreement for Jardines De Rivera.

- Mayor: Residents want three-way stop signs similar to what we have on Acosta, as well as speed humps to slow people down. There has been a call for a short-term flood remedy before the next rains.
- o MPT Herrera: Requested workshop meeting to discuss city manager contract which auto-renews November 18th. The meeting was scheduled for November 9, 2021, at 5:00 p.m.
