b) Consideration and action to approve Payroll expenses for public safety-first responder employees at the Anthony Police Department for a total of \$3,393.34 from CARES Act grant Fund GL 297-01-91900. Presented by Payroll/Procurement Clerk & Chief of Police

- Procurement/Payroll Clerk: The total admin leave cost for PD since March 13th through December 5th was a total of \$3,393.34. Ms. Cummings, Budget Analyst with DFA said we can ask for reimbursement for admin leave. She recommended we add a new GL line item to compensate the police department. Officers are frequently providing direct patient care and have immediate close contact with the public regularly. Suggests one lump-sum payment of \$377.03 for each officer for their dedication to citizens during this global pandemic.
- Chief Ordonez: March 21st was the first call that we had with universal precautions, meaning that there was a person there that tested positive for COVID-19 or was experiencing symptoms. This goes a long way to show our appreciation to the police officers.

- c) Consideration and action to approve task order for Wilson & Co to prepare Bidding items for Adams Park. Task order will be paid using Parks and Streets Bond PPRF 4850. *Presented by Projects Coordinator*
- Projects Coordinator: This is the first step of Adams Park Phase 1 project, task order is for bidding services.
- MPT Herrera: how much is the bidding services?
- Projects Coordinator: it is \$15,453.16 including CES Fee of 1.25% and NMGRT
- City Clerk: correction on Agenda item, the correct bond number is PPRF 4890
- Trustee Silva: task order says, this task order proposal does not include Construction Management Services. Do we have any idea what that's going to cost us at this time?
- Eric Hamilton, PE: We are tracking the additive alternate items to be above the available construction funding through our engineers estimate. We had established potential conflicts with bidding the restroom engineers recommended excluding the restroom facility from this first bidding because it would likely result in rejection of bid and bidding protests. This is the reason we are not bringing forward a task order for pre-construction services and construction management.

- d) Consideration and action to approve renewal of translator agreement. Presented by City Manager
- City Manager: The draft agreement before the Board is simply a version that was approved last year about this time with the dates changed. There were no other material changes to the document.
- Trustee Gameros: on item 3a second sentence add "minutes".
 - Move 3b up to 3a
 - Suggested to change mileage sentence to \$27 roundtrip. It is a repetition, if you multiply \$0.45 and the 60 miles you get the roundtrip
 - **Trustee Silva:** I would be OK just leaving the IRS standard mileage rate per mile and let the translator submit her paperwork. Place- contractor shall be compensated for the travel at the standard mileage rate at \$0.45 per mile.
 - Alan Dahl: looking at my original version of this agreement, and the changes before you, this draft has some significant differences. My first concern is, do we know that the IRS standard mileage rate is \$0.45/mile? Requests to look over this agreement before going further with it.
 - City Clerk: That's what we had as the most recent draft.
 - Trustee Flores: Suggests postponing the item to allow the city attorney time to review it.

- e) Consideration and Action to approve the amended Section 8: Holidays & Section 5:3 Overtime Pay/Compensatory Pay of the employee handbook. *Presented by City Manager*
 - City Manager: This item is an attempt by staff to align two sections of the employee handbook that are not in alignment. Our payroll and procurement clerk brought it to our attention. Section 5:3 refers to paid holidays and sick leave as hours worked while there is guidance from various sources, including the New Mexico Municipal League that it is should not be considered hours worked.
 - Trustee Silva: Why do we need item C- "The city manager may make an executive decision to release employees with pay and must notify the Board of Trustees prior to the release of employees", if the holidays will be approved by the board with a resolution?
 - City Manager: That is a legacy policy from before my tenure where the mayor could release employees on those days. I do not see a problem with removing the sentence. It is at the Board's discretion. That is one of the few things that were not changed since the handbook was updated last.
 - Mayor Trujillo: The City manager or the Mayor would be able to use this if something drastic happens in the City of Anthony, not just the holidays.
 - Trustee Silva: Agrees there should be that ability just not on this section.

- g) Consideration and action to approve \$4,680.00 payment to South Central Regional Transit District Membership payment FY 20-21. *Presented by City Manager*
 - City Manager: This is renewal of an annual membership that the City of Anthony has with the transit district. This was something new for both of city manager and procurement clerk and so the city clerk asked that we bring this forward because the amount is beyond the city manager's spending limit. Also, this is a higher amount than the city has paid in the past.
 - Mayor Trujillo: Every municipality with the South-Central Regional Transit District pays a membership fee. Last year, they made a mistake and invoiced us about \$3,000, which was a little less than what should have been invoiced that is why the fee is now \$4,680, which should have been the fee from the beginning.
 - MPT Herrera: Who has the original contract?
 - Mayor Trujillo: I have it. The City should have a copy too. ** Mayor emailed staff and BOT a copy of SCRTD budget showing amounts paid by each City.
 - City Manager: All the City has are the transit district's bylaws and the membership resolution does not mention fees.
 - City Clerk: I was able to find 2 resolutions on this matter, both to join membership with no amount mentioned. I reached out to SCRTD requesting a document with costs and how it was calculated, all they sent was bylaws.
 - MPT Herrera: How long have we been paying them?
 - City Clerk: Incode shows 2 payments: 1^{st} Year = \$3,510, 2^{nd} payment = \$4,680. If this is approved, it will be the 3^{rd} year.
 - **MPT Herrera:** Is the amount set or can be lowered?
 - Mayor Trujillo: The numbers are fixed; We can invite Mr. Armijo to explain in the next board meeting
 - Trustee Gameros: Requests to see their calculations & how they came up with this amount.

• City Clerk: Correct MPT, City Clerk job description states that the clerk is the custodian of City records. According to NMML the authority to do that job comes from a resolution, not a job description. They advised the clerk to bring this resolution to the Board. After reviewing all clerk's files, we were not able to find this resolution and so, it will be the first time we are adopting this. The City adopted record retention schedule for the first time in 2019 with no custodian of record resolution.

- Trustee Flores: We closed down the codes and the animal control at the beginning of the year. We had put some money in their budget. What became of that money left?
- City Manager: So, I think you might be asking about the money from last fiscal year, but remember, the budget is just a projection. That is, this is what we think the city is going to spend. If the city doesn't spend it, then the budget closes and then a new budget opens. It's not real money. There's no money leftover or anything like that.
- The board approved the budget that included two positions that were then combined. One of them was increased to a supervisor position. That person, who was the animal control officer, is now running the department, including the budget.
- **Trustee Silva:** Trustee Flores is referring to the current fiscal year. The question is, after we created the new Neighborhood department, did we create a line item for it? What happened to the old-line items from the codes and animal control department?
- City Manager: I'm not sure, I understand. The only thing that happened was, instead of animal control, now it says Neighborhood Services Supervisor in our system. Code Enforcement Officer became the neighborhood Services officer. The rest of the documents remained the same because there is still an animal control expense.
- Trustee Flores: So you're saying that Neighborhood Service is using the money that is for animal control and codes?

- City Manager: What I'm saying is that the Neighborhood services supervisor is now using the animal control budget and the Neighborhood Services Officer will be using the codes enforcement budget. We have made changes to the budget and so what you have from July has not been updated. Code enforcement officer was just renamed to Neighborhood Services officer under the same budget and the same amounts. The big change is that both positions are no longer under other departments then reclassify the positions under one department. There was no transfer of money
- Trustee Flores: I am going to say this because I am trying to understand, and so that it's also on record, and if you could just give me less attitude please, I would appreciate it because I have to ask questions.
- City Manager: Forgive me trustee Flores, I am just tired, ma'am.
- Trustee Silva: Just for clarification, I can see where Trustee Flores is coming from because you got to keep in mind that codes were 101-09 under the public works and animal control was 101-11. So, the monies that was allocated for codes came under public works and the money that was allocated for animal control came under the police department. So, in this new neighborhood position, what is going to be under? which line items?
- City clerk: If trustee Flores is requesting staff to update the budget, we can pull funds from the two different departments, and we made them into one to correspond with new positions. Codes and Animal control have always been reporting to other departments, but their budget was always separated from the Police department and public works departments. Budget can be adjusted in Q2 or Q3 to combine the two positions.
- **Trustee Flores:** Yes, if other Trustees agreed to this. I think it will make it a little easier. Just so that it looks organized, because right now it is a little bit confusing. As far as the money and whatever is left in there, we need to know where it is going, and the board needs to approve it.
- Trustee Silva: According to the organizational chart, it shows two positions are reporting to Neighborhood supervisor, is that correct?
- City Clerk: Correct, one position is being filled this fiscal year, but the other position will be brought for board approval next fiscal year.
- Trustee Flores: IT manager report said that we are working to improve the Wi-Fi system for the city currently, don't we have fiber optic?
- City Manager: What IT manager is trying to do is to deploy additional Wi-Fi hotspots throughout the building.
- Trustee Silva: Requests Christmas lights at City Hall.
- Mayor Trujillo: Wish everybody a Merry Christmas and I want to thank the staff for keeping our city going and for many improvements. Stay safe and please take care of the elderly and the people that have underlying conditions.
