7. PRESENTATION

a. Presentation on the Department of Parks and Facilities, *Presented by Javier Herrera*.

Mr. Herrera gave presentation on the goals and expectation from this department. Two aspects of this department would be the Programming side which would focus on facility use, special events, parks commission, sports leagues and community programs. On the Administrative side, Parks and Facilities would focus on grant writing, lease agreements, operational budget, fee schedules, signature event resolutions and budget management control. Some current projects and future projects include developing Policies and Procedures, establishing parks Commissions and Sports leagues, Phase I&II for the Multi-Generational Building, Urgent Care Center, creating a fee schedule, Soccer Filed Lighting, Adams Park Sports Lighting, Dos Lagos Lakes and Amphitheatre and Transfer Station.

b. Consideration and Action to approve Resolution 2023-0XX for the donation of miscellaneous classroom equipment in accordance with Chapter 3-Municipalities, Article 54- Sale of Lease of Property, Section 3-54-2-Sale, exchange and gift of property, *Presented by Interim City Manager*.

Upcoming meeting to present the resolution to donate these materials to South Central Reginal Transit District who would like to use that equipment if the City has no use for it. Inventory has been taken of equipment and material that will be donated, in compliance with the state statue. Trustee Holguin would like to use the materials for City facilities, including city administrative buildings, buildings that the City is leasing, the Multi-Generational facility, as well as the Transfer Station to help eliminate costs and bring revenue for the City. Trustee Silva, would perhaps like to purchase a shed to store the materials to hold off before donating to get use of the portable they are currently being held in.

City Clerk increase Professional Services and Printing and Publishing. Courts would like a hospitality added \$1,000. PD will have adjustment on vehicle maintenance and dispatch. Library increase for the reading program. Neighborhood Services Department, adjustment for the vehicle maintenance. Creation for Funds for the Portables and Transfer Station, SRO and Library Grant.
