- **City Manager:** Finance officer realized that there actually was an impact to the general fund, which is reflected in the language of the resolution.
- **MPT Herrera:** Some departments did not spend on wages majority of the time, why is there impact on general funds?
- City Manager: Estimates right now is that the City is operating at a \$400,000 surplus. There might have been some room to move some of those line items over from the wages. There was no line item for Neighborhood Services Supervisor computer. Supplies in that department was also under-budgeted.

- **Finance officer**: There will be more changes in the last quarter. Rent expense makes majority of the difference.
- **Trustee Gameros**: That needs to come out; The board did not approve to pay rent.

- **City Manager:** There were very few material changes to the agreement. Charter Communications franchise fee remains the same. Alan, City attorney was able to review the agreement and he agreed to the proposed changes.
 - We asked Charter to consider deploying new services to some of the newly developed areas of the City. Chatter retains the right to not necessarily deploy services, if it didn't make economic sense for the company. That was the only request that was made by the City, that was really denied by the company.
- * Trustee Silva: For the record, I work for CenturyLink, I will refrain from voting. What services are they bringing in?
- **City Manager:** I can't speak to that Trustee. The original agreement was with Time Warner Cable. I believe that the idea is that they're deploying cable services and fiber.
- * Alan Dahl: The issue was binding them to offer services to all future developments or annexed portions of the City. They were unwilling to commit to that, but are willing to commit to provide services to the city as it currently exists, which is defined as the geographic boundaries of the city.

11. ITEMS FROM THE CITY CLERK

- ❖ City Clerk: Presented capital outlay questionnaire. Projects coordinator was given a week to submit questionnaire which cannot wait till next board meeting. This is for \$40,000 for police department safety equipment & speed awareness monitors, \$70,000 for Anthony Parks and Recreation (construction of recreational facilities and restrooms at Adams Park), \$100,000 for Duffer Lane & pedestrian access including safety street lighting and \$650,000 Anthony Public building & facility (to acquire land, easements and construct building).
 - **MPT Herrera:** Request staff to contact Representative Gallegos staff, there was an additional \$50,000 for police department junior funds.
 - Sending thank you note to the anonymous person who submitted my name for NM Clerk of the Year award. Anthony clerk was nominated which is a great reward. I am humbled for consideration.
 - City Clerk has fulfilled all the requirements of the Certified Municipal Clerk (CMC) Program offered by the International Institute of Municipal Clerks (IIMC) and has earned CMC designation. I'm grateful to continue serving Anthony community.
 - NMML through Clerk school reminded clerks to send back information on notice of quorum. The board should try and avoid a meeting that created perception of public business discussion.
 - Attorney general staff trained clerks on OMA. Cities are to work with their attorneys to determine if committees selected by the board are subject to OMA (i.e. RFP committee meetings). Procurement code has to be followed.
 - *OMA allows minutes to be adopted by the board in any of their meetings, workshops included.*
 - Clerk has to attend final classes in fall semester. Requested board to move regular meetings from Wednesdays, Tuesdays or Fridays. City attorney and Mayor have other conflicting schedule on Tuesdays.
 - **Mayor Trujillo:** Requested clerk to add resolution for consideration and action on next meeting. If we chose Fridays, Mayor requested accommodation to attend meeting online.
 - A resident requested a copy of ordinance with qualifications to be a judge, mayor or trustee. Staff was able to find an ordinance with qualifications of a judge, but none for trustees or mayor.
 - **MPT Herrera:** Request NMML for State Statues. That is all we need to offer. All I remember is that they told us that we had to be over 18, a US citizen and living within city limits. We don't have to have any other qualifications at all.
 - **Trustee Flores**: I feel that for now, since that one person called and asked for information already, we should just leave it as it is. After these elections, then maybe we can think about changing them.
 - **Trustee Gameros:** I believe that we should look into the matter and get the written opinion from the municipal league in case something else comes up later on in the future. Check Section 3-12-2 NMSA 1978

12. ITEMS FROM THE CITY MANAGER

City Manager: One of the items that did not make the agenda this evening was a presentation from Wilson on Traffic Calming measures. Trustee Silva requested the study for streets with speeding problems, Wilson & Company conducted the study pro bono. Staff is really trying to adhere to our own policies around cutoffs for agenda items.

13. ITEMS FROM THE MAYOR AND TRUSTEES

- **Trustee Flores:** Requested update from City Clerk on the mail box for trustees.
- **City Clerk:** We found USPS style boxes for about \$310. Clerk budget is depleted. We were not able to purchase.
- **City Manager:** Recommended that public works build one box for items like resolutions and ordinances, things that need to be signed by everyone. All trustee and Mayor would have the key so that you all could come sign when available.
- **City Clerk:** Chief of police has some funds in police budget that she offered to issue clerk for this purchase.
- * Trustee Silva: I support that individual who submitted city clerk name for the award. I really do appreciate the job that you do and it is definitely a nomination well deserved.
- Reminder to staff to put emphasis on the stop signs.
- Soccer field grass is dying, City put a lot of funds to that field to let it die. I've been to that field, maybe about six times already and one time it got saturated. It seems like there's always an excuse for not watering the grass and it's getting to the point where I'm going to start asking people to be reprimanded for not doing their job. We didn't put the money into the grass to have it look mediocre like that. I understand we're not under normal circumstances. There are things to take care of, you can see all the weeds growing up around the front of the building and on the sides. We are starting to have people come back in, we want to make sure that our first impression is a good one.
- **MPT Herrera**: What is the update on street lights?
- Request for copies of all the classes that the city manager has been taking, just to see if there pertain to the city or not.
- There are pot holes on Clark & Van Buren Street / Clark & Madison streets. There was no evidence of work done on Clark and Madison Street. Staff say they have been working on it. Residents say they have not seen this worked on.
- **Trustee Silva:** Public works filled those potholes on Van Buren. Water actually settles forming a puddle which washes everything out. In all fairness to public works staff, they patched it multiple times. That doesn't mean that we shouldn't go back until we resolve that issue. Maybe, we need to stop patching and look into long-term solutions.
- **City Manager:** Street lighting pricing was just received on Wednesday evening/Thursday of this past week, so I do have some information.
 - I will give you all the details for my classes, these are mandated by the board for this position. Classes are for Certified Public Manager program.
 - As Trustee Silva explained, the intersection in question has been a problem because over time, water ponds there. Water district also discharges water from the fire hydrants and water collects creating potholes. I have brought this up to public works just like I did the grass and just like I did, everything else, including the sign that needs replacement. Public works is short staffed and we are trying to recruit

for those positions. We waived assessment tests for these positions. Public works is doing everything they can with regard to the intersection and with the grass.

- **Trustee Flores:** Sometimes, when our public works fill in the potholes and some naughty kids or just people spin their tires to break the repair. We are very short with the public works staff, we need more people in that department.
- * Mayor Trujillo: I just wanted to congratulate city clerk for your nomination and thank you for all you do.
