### 6. CONSIDERATION AND ACTION

- A. Consideration and action to approve the use of Junior fund grant No. ZD9029 to design Adams Baseball Park.
- **Projects Coordinator**: There is a remaining balance from Junior funds of \$63,795.60 which the Board allocated to be used for design at Adams Park Baseball field.
- Staff plan to use \$33,101.10 for design & \$30,694.50 for the purchase of a Baseball field fence.

- B. Consideration and action to approve the use of Junior fund grant No. ZD9029 to purchase equipment for Adams Baseball Park.
- **Projects Coordinator:** Eric Hamilton got us 3 quotes: \$31,606.50 from Aluminum Athletic Equipment Co; \$ 10,328.80 from Nets of America Inc; \$33,226 Option 1 Sports Edge, \$26,577 Option 2 Sports Edge.
  - Nets of America did not include a backstop system in the quote.
  - Staff recommend Sports Edge, they provided a wealth of materials, they have products superior to others.
- Trustee Silva: is this from dugout to dugout?
- Eric Hamilton: That's correct, length 190 ft full protection 30 feet high.
- Trustee Flores: is this mesh or wire?
- Eric Hamilton: Sports edge are offering powerhouse baseball backstop system, reduces visibility, and has great aspects to it. There will be 3-foot concrete wall, behind that wall is where the seats will start with an elevated view wall will be from one dugout to the other dugout 33 feet of coverage.
- Trustee Gameros: The best price is from Sports Edge option 2 at \$26,577 including shipping &handling, if we add tax we would be within the budget of \$30,694.50
- Trustee Silva: What is left on the grant after tax? Choosing Option 2 of Sports edge based on the cost.

- **Eric Hamilton:** the tax of 8.375% brings us to a total of \$28,802.80 leaving us with a grant balance of roughly \$1,800, Eric Can provide quotes for small items to clear the balance.
- Trustee Silva: thank you, that will suffice for that fund.
- Trustee Gameros: let it reflect on minutes that we are choosing sports edge for the amount \$28,802.80

- C. Consideration and action to approve ESA quote of \$5,252.74 to pave Lil' Adams Park walking path under CES contract.
- Projects Coordinator: Since KNMB canceled New Mexico cleanup due to Covid-19, we have \$4,902 on the grant.
- Staff got quotes through CES vendor to make the process faster, ESA gave two quotes one was for the construction of a sidewalk around the existing playground equipment for \$5,252.74. The second quote was for the construction of planter for landscaping around the welcome sign at \$4,608.00
- Trustee Gameros: are you asking for us to choose one or the other?
- **Projects coordinator:** yes, one of the items was over \$5,000 so staff had to put this on the agenda for approval. The difference that the City has to pay is \$350.74
- Trustee Gameros: Chose walking path around equipment, the city has to make up the difference if we choose walking path
- Trustee Silva: Do we have a plan of where we should pull the balance from?
- Projects Coordinator: General funds
- Trustee Silva: Suggested using public works fund used for sprinklers
- City Clerk: We have a balance of 3,800 recreational expense fund No. 101-07-70000
- Trustee Silva: Suggest we use recreational fund under public works
- Trustee Gameros: I agree, what is the fund number for that item?
- City Clerk: it is 101-07-70000 recreation expense fund
- Trustee Gameros: let it reflect in the minutes that we will use \$350.74 from line item 101-07-70000 to add to KNMB fund.
- City Clerk: is CES fee included in the quote?
- **Projects coordinator**: Yes, this is including CES fee & NMGRT
