Consideration and Action to approve a resolution authorizing acceptance of Colonias
 Infrastructure Fund (CIF) Project No. 6101-Funding Offer; Lee Ave. Roadway and Drainage
 improvements project from the New Mexico Finance Authority, *Presented by the Special Projects Coordinator.*

The Special Projects Coordinator explained to the Board that earlier this year a resolution was approved to go for this funding, this is simply a technically to apply for those funds and are a requirement. Trustee Silva requested it be explained further for the benefit of the public, this funding would be for the roadway and drainage improvements for Lee Street. The total funding is \$200,000 with a 10% loan for a 20-year term, the loan would be for a total of \$180,000 while the loan will be \$20,000. The improvements would cover from the State Line to Acosta Rd. Trustee Holguin asked why, under this resolution, is the Mayor designated as the City's representative and not the City Manager. The City Manager responded by stating that this resolution is a template that was provided by the NMFA, and it is their policy.

c. Consideration and Action to approve a resolution authorizing acceptance of Colonias Infrastructure Fund (CIF) Project No. 6102-CIF Funding Offer; Solid Waste Transfer Station from the New Mexico Finance Authority, *Presented by the Special Projects Coordinator*.

Similar the item before, this is a resolution that must be approved in order to receive the funding, this funding would be for the Solid Waste Transfer Station which would total \$800,000 with it being 90% loan with a 10% grant. The 10% loan would be in the amount of \$80,000.00 and a 90% grant in the amount of \$720,000.00. Trustee Silva asked where this loan match would come from, City Manager explained it was not accounted for in the new budget because it was not yet approved, we would need to come back before the Board for that budget adjustment for that match.
