- 12. ITEMS FROM THE CITY MANAGER- NONE
- 13. ITEMS FROM THE MAYOR AND TRUSTEES
- *Trustee Silva* Ask City Manager to look into the intersections of Clark and Church street; There are 2 huge potholes with the shape of a square that showed up again. Vandalism occurred at my Business location for the third time. Would like to have an update on the lighting situation?
- Mayor Trujillo- This week they will be starting at Stateline.
- Trustee Gameros- Would like to know what is the status on the 4<sup>th</sup> quarter report?
- City Manager- The 4th quarter report and budget report are submitted and DFA staff is reviewing both as we speak. I will be sending an update to the Board as soon as there is one.
- Trustee Gameros- Would like to know the status of Dos Lagos: On the lights, water wells, electrical meters?
- City Manager- A waste water discharge permit was received by staff and that will be changed to City's name and pay the small fee. A lot of the greywater infrastructure that the City will need is already there. Electrical work is needed and pending at the moment. City staff hit a pause on much of the Dos Lagos issues. Public works supervisor is off this week and potholes will be one of the main priorities when he is back. Will revisit the Dos Lagos issues when he is back.
- Trustee Gameros- What is the status on the lease of South-Central Waste Authority and Magistrate Court?
- City Manager- City commissioned Fair Market Rental Study was received and shared with SCSWA. Language has been suggested and staff will work with city attorney to prepare for the Sept. 2<sup>nd</sup> meeting.
- City Attorney- Agree with City Manager
- Trustee Gameros- May I get an update on the RFP for the solid waste ordinance?
- City Manager- Draft is being viewed. Proposed draft will be presented to the board soon, along with changes to the memorandum of understanding with AWSD. It is complicated process and moving forward.
- Trustee Flores- Why did the budget take a long time to be submitted to Santa Fe?
- *City Manager* The budget submission was a group effort and LEPF carry over was approved by the board late in the process, which slowed the DFA staff approval, but budget is officially submitted and under review.

- *Trustee Flores* Would like for City Manager to take a really good look at this because the City has never been late before. Would like to know what is the status on hiring a Finance Director; The board has asked for months to hire someone.
- *City Manager* The City has offer and acceptance. August 31<sup>st</sup> 2020, will be the first day that our new Finance Officer will start.
- *MPT Herrera* What is the hold up on the lights on 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> street?
- *Mayor Trujillo* I spoke with Mr. Jaquez; He was working on a previous project in Sunland Park and was a little busy, but he will start this week. He explained which light will not be able to be installed due to transformers, mainly on Stateline on New Mexico side.
