7. ITEMS FROM THE FLOOR

a. Rosalinda Aldaz:

- I would like to let you know that I've been a lifelong resident of Anthony and an employee of the City of Anthony for almost seven years.
- I'm no longer an employee and I'm here today as a citizen to inform you of the way that my termination was handled.
- I requested a hearing with the board of trustees and was advised that I had a conflict of interest. I was terminated on the 26th of June of this year for performance standards.
- I do feel that Ms. Hall called Diana and myself to her office and told us that she was going to remove all the write ups and complaints in our files for 2019 and make a fresh start in 2020.
- I do have various messages from Diana.
- On June 11th, I was at the library. I was listening to a reading class that I was in charge of.

- I noticed that Ms. Hall came in with a patron who usually rents out movies. The policy during that time was absolutely no one was to be permitted inside the building with us. Ms. Hall went over this with us because we both have underlying health issues and with COVID-19, we were more at risk.
- I looked up at her and asked her what she was doing, Ms. Hall looked at me and rolled her eyes. I then looked at Diana, and Mary was rolling her eyes. I did tell Diana that I had seen that.
- Mr. Dominguez informed us that I was going to be terminated for complaints against me.
- I also received various messages from Diana, concerning my termination, where she was very confused and didn't know exactly what was going on and why I was being terminated.
- My hearing took place on July 27. Mr. Carranco served as the hearing officer. I feel discriminated because he didn't listen or pay attention to the dates.
- My post termination hearing letter had incorrect dates and I feel that I was discriminated against as he was not paying attention to my case.
- I don't wish to make excuses for the way that I acted. I do suffer from underlying conditions, fibromyalgia, which causes me to have mood changes, which I never knew was going on.
- I was not allowed to speak to the board, but I do feel that I can share today. I do not see how a supervisor should be able to change policies to their own free will risking her employee's livelihood during a pandemic.
- The person in charge should be reprimanded so that the future employees are not intimidated or scared to come forward and complain. I believe my termination should be revoked and re-instated.

- g) Consideration and action to approve **Resolution 2020-023** a resolution approving final Quarter financial report for the fiscal year 2019-2020 for the City of Anthony, NM. *Presented by City Manager*
- City Manager: The City of Anthony has to submit a quarterly report to DFA to compare the financial performance of the City against the budget. The variance in final financial report, has to do with the original cash estimate made at the beginning of the fiscal year, which was unfortunately overstated by quite a bit.
- Sent an e-mail to Juan Garcia, our outside auditor to see if he might be able to assist with correcting this.
- Our contracted Finance Officer explained this is something that the auditors usually will find and correct.
- This is really just about reconciling the estimates that were way off from the beginning of this fiscal year.
- Trustee Gameros: The auditors will probably be the ones to catch these errors or the new finance officer. Was CDBG \$5,000 account added to claim on cash?
- City Manager: I believe the \$5,000 was included. I'm trying to get our auditors to help with that. The issue is really just a matter of the City's cash position being overstated on our books.
- Trustee Flores: Request to leave the balance as zero instead of the dashes on report. Do we still have line item 296?
- O City Clerk: It's not in your report for the previous year, but it shows on our budget for this year.

- i) Consideration and action to approve Anthony Police Department COVID-19 pandemic response and protocols. *Presented by Chief of Police*
 - Chief of Police: I basically generated this document for the purpose of having a written protocol and response to the pandemic available to our police department.

- We do not know how long the pandemic is going to last and are expecting there's probably going to be either outbreaks in the fall.
- The purpose of this was to be prepared to function in a variety of rapidly evolving situations.
- These guidelines are meant to supplement the response and not replace any emergency orders from the Board or Governor.
- This protocol is to essentially help prepare the officers to safeguard themselves and their community as the police are required to report to work and carry on with our duties during this pandemic.
- **Trustee Gameros:** You have definitely created something that the city needed. Request the city manager incorporate similar protocol into City staff procedures as well. Employees need to have something written, so they may be able to refer back to it.
- MPT Herrera: We should have our own protocols in place and not just depend on the State or County.

- j) Consideration and action to approve purchase of Protexus cordless electrostatic COVID-19 fumigator. *Presented by City Manager*
 - City Manager: The documents before the board include a quote for this equipment as well as an invoice for the recent disinfecting done at the municipal complex.
- The cost of disinfecting the complex was \$2700, which is about equivalent to the purchase of this equipment. This is a much more sustainable solution than contracting out the services.
- MPT Herrera: How many tablets will be needed?
- City Clerk: It depends where you will be decontaminating. There is a table of ratios of tablets needed for different types of contamination.
- MPT Herrera: I think that the entire building is more than 8000 square feet. How much of those tubs will we need?
- **Trustee Silva:** Those tubs, they actually come 256 tablets per tub. On the last page, where it's actually showing the disinfection solution, for example, for food contact, surface sanitizer, what you're going to do is add one tablet per quart, and then one tablet of the 3.3 for 2.5 gallons.

- Mayor Trujillo: We have an ordinance here for Board of commission, the first reading us for 8/5/2020 approval on 8/19/2020.

- **Trustee Gameros:** Second page, Section 4B says: "Members of the Planning and Zoning Commission shall be residents of the City." There are two of the current members that aren't residents of the City. We need to change the language here.
- Trustee Gameros: Suggest for it to read: "The majority of the members of the Planning and Zoning Commission shall be residents of the City".
- Mayor Trujillo: Didn't we have 1 or 2 out of the city limits before?
- Trustee Gameros: They have been, but we never changed the ordinance.

- Mayor Trujillo: Yes, request staff to check.
- Trustee Gameros: Staff can check April 20, 2016 minutes. I think we should extend the term from two years. I know, for myself, it took a good two years to really know what's going on in the position.
- Trustee Flores: It's a good idea to extend it, but I would suggest that maybe not at the present time due to the fact that we already elected these people and we don't want anyone to say that just because we elected certain people that we're giving them more time. Maybe we can do that for the next election, but it would be a good idea to extend it.
- Mayor Trujillo: Ok, so we'll go ahead and make changes, we will bring this item back on August 19.

13. ITEMS FROM THE MAYOR AND TRUSTEES


- o Trustee Silva: Request staff to change on the time on library notice board.
