- **Betty Gonzalez:** I would like to bring to the trustees' attention the fact that there are continuous mistakes on the presentation of notification on the agenda to the public.

- b) Consideration and action to approve Baseball Field Equipment for Adams Park, using Jr. Fund. *Presented by Projects coordinator*

**Projects Coordinator:** Staff apologizes as they did not have the three quotes available for the board packets in time. The third quote came in same day of the meeting.

- At the last meeting, the board approved a quote from Sport Edge for a backstop, with is a total of \$24,384. The actual amount decreased and we now have a grant balance of \$6,309.
- Three Quotes were secured for dugout benches (15 ft. long with players platform) and 20 tall foul poles.
- Quotes: Sports Edge: \$6,747.43; Beacon: \$6,393.53; Sport field: \$8,748.03
- Trustee Gameros: If we choose Beacon, (it seems like the lowest price), the balance will be paid by the city?
- Projects Coordinator: Yes.
- Trustee Silva: Based on the balance we have; I agree to go with Beacon.

- c) Consideration and action to approve South Central Solid Waste Authority (SCSWA) rental contract. Presented by City Manager Rafael Leo's: I thank city staff, the city attorney and city management for promptly moving on SCSWA's recommendations for the lease agreement.
- SCSWA staff had the opportunity to review draft lease agreement; The entire staff is in support of this, as it stands. The language has improved to our satisfaction.
- City Manager: I emailed the Board a response from our attorney on the prescribed process to follow with municipal leases.
- Alan will provide a draft or a template for the ordinance. We have an appraiser quote of \$3,500 plus tax.
- While the Board can certainly enter into this agreement, as it did with the Administrative Offices of the Court, I would recommend that we follow the process.

- The ordinance does not go into effect until 45 days after approval and the appraiser would need about a month to do the work.
- Trustee Gameros: I read the state statute, and I do believe that you need to follow the process according to the statute.
- Trustee Flores: Isn't this government to government entities?
- Alan Dahl: The statute, unfortunately, does not provide an exception for government to government lease agreements. In my letter, there are exceptions to this requirement, like joint powers agreements. Governments are allowed to contribute their own real estate to the creation of a new agency, when they're working with another governmental entity. There's also the exception for local economic development agreements, where a city, without assessing the value of their property, can actually give that property to a business that comes into town.
- But unfortunately, I have been totally unable to find an exception to the appraisal requirement, even if it is another governmental entity. And so, unfortunately, Statute does prescribe that there has to be an appraisal for the land if it's worth over \$25,000.
- Rafael Leos: Within the language of your lease contract, provision 23, where it says "This Agreement shall not be modified or altered except by written instrument, duly executed by each party to this agreement". If, let's say, we move forward with this lease with the intent that a letter can be produced, to say a modification will be needed to be made once an appraisal has been done.
- Alan Dahl: As we read the law, we can't even necessarily enter into the contract until after the ordinance is passed and the appraisal done. Our advice as legal counsel is to follow the statute.
- **Trustee Silva:** I understand the sense of urgency with their broadband provider, but at the end of the day, I think the most important thing is that we follow the state statute.

- d) Consideration and action to approve maintenance agreement for signals, intersection lights, flashing beacons and roadway lights for NMDOT project E100220 on I-10 and NM-404 interchange. *Presented by City Manager* 
  - MPT Herrera: contract says we must pay the cost of replacing LED lights. My other concern is that the contract says we must have a certified repairman that knows how to repair all the controllers. Public works department cannot do that. We have two other intersections with streetlights; Are we going to pay for those?
  - And it's going to cost the city a lot of money, especially if somebody accidentally hits a controller. We don't have anybody that knows how to fix a controller or program it or anything like that.
  - City Manager: The City has no choice but to enter into the contract as this intersection fall within the city tax boundary.

    The agreement is pretty standard, as with other municipalities. It is also a significant investment in the city by the state for a project that's really going to bring a lot of benefit.
  - Trustee Silva: On page 2 of the contract, it seems like there's a portion of it that's going to be shared by the department of transportation.
  - City Clerk: Sunland Park told me it's common to have these agreements and they have entered into one where they are maintaining lights. They sent us their agreement similar to our draft with NMDOT and they sent the name of the company they contracted to meet their end of the agreement.
  - Since we are not capable of meeting maintenance portions of this agreement, city can contract third party for those services like Sunland Park.

#### 10. ITEMS FROM THE CITY MANAGER

- City Manager: This morning, we received an e-mail from our friends in Anthony, Texas around a request to help with coordination of a Fourth of July parade. They did apologize for the short notice. Public Works supervisor was kind enough to furnish an agreement that we can enter into with New Mexico DOT, but it does require a 30-day notice and we're well inside of that time frame. I also brought this up with our Chief of Police.
- Staff is skeptical that it will be approved by NMDOT, however, we have to take into consideration the current public health orders against any mass gatherings and this would definitely qualify as one.

#### 11. ITEMS FROM THE MAYOR AND TRUSTEES

- o Trustee Gameros: None
- Trustee Silva: Sent city manager an e-mail regarding Adams Park and the current situation with the weeds there, but you could, set aside an hour or so to start little by little.
- o Soccer field had dried up a little
- o Trustee Silva: I did speak briefly with our public works supervisor about the sprinklers.

- City Manager: I think he had said that there was someone who might have some tampering with the sprinkler timers. Sprinklers are running on the evenings to minimize the amount of evaporation and maximize the saturation.
- We are working on renting equipment to tackle the former golf course; It is about a \$5000 expenditure for rental equipment that will make the task a little more manageable.
- We had residents reach out about reserving a soccer field. My understanding from our Public Works Supervisor is it is ready to go. We just have to update the forms and make sure that we're prescriptive about how to use the field safely.
- Trustee Silva: if we're going to pay \$5000 to go rent the equipment, plus occupy our employees at the same time, why not go and pay somebody \$5000 to come in and cut the grass?
- o City Manager: We need estimates on that and can prioritize the grass that is closer to residences.
- o Trustee Flores: None
- o MPT Herrera: Suggest talking to some of the area farmers or ranchers around here for disking job.
- o Now that the Water Trust Board funding has been denied, how is that going to affect bringing back the ballpark?
- City Manager: We haven't had any conversations yet about the impact of that decision. Staff and Wilson have a meeting on this scheduled for this Friday.
- City Clerk: Projects Coordinator is planning to present on July 1,2020 on Water Trust Board decision, Eric will attend that meeting.
- o MPT Herrera: Mayor, I have a general question to you and the rest of the board regarding City Van. We need to install GPS and do maintenance to it. When are you bringing it back and comply with City vehicle policy?
- o Mayor Trujillo: I will be taking it next week because I have a meeting in Las Cruces.
