## 5. CONSIDERATION AND ACTION


a. Consideration and Action to approve the reconstruction of Adams Street in the amount of \$114, 653.11, using NMDOT LGRF Cooperative Agreement funds CN HW2L100558, Presented by City Manager.

This project will be a full-depth reconstruction of Adams Street, between Clark Ave. and Lee St. This would be paid for by the NMDOT LGRF Cooperative Funds that were recently awarded and be done by the City's On-Call Contractors. Trustee Silva misunderstood and believed this project was going to be funded by the property tax increase, after the clarification he requested this reconstruction continue all the way to Kalar. City Manager informed the Board that he will be providing a list of the recommended streets for approval this coming fall, which will be paid for by the property tax. Progress continues to fix the streets; Trustee Silva questioned why it would be until fall that we would see these streets on the agenda, the City Manager explained that funding could take months before it's received. Trustee Silva further questioned why the property tax increase funds are not being utilized for these streets when according to the last budget workshop it was reported there was a significant amount there. The City Manager assured that he would
