
- A. Work session to discuss and make modifications to the following:
  - 1. Resolution 2012-36 A Resolution Expressing a Desire for the Federal government to Enact Comprehensive Immigration Reform.  
*State of Texas just passed a resolution where police officers have a dual role, acting as ICE agents when pulling someone over.*  
*Chief Rodriguez stated with COA Police Department, there has to be reasonable suspicion and probable cause, to arrest someone. He enforces a strong stance on not being an immigration officer.*  
*Ramona (attorney) stated the City should have in writing a policy where it clearly stipulates the Police Dept can not and will not perform immigration duties nor ask for immigration status.*  
*Will Anthony be a "sanctuary city?" This may disqualify us from receiving federal aide for projects. Ramona will draft the amended resolution with the help of Brian Erickson from Dona Ana County. Trustee Gonzalez recommended to keep second and fifth "whereas."*  
*MPT Ramos would like for it state "safe community for all."*
  - 2. City of Anthony Library's Collection Development Policy and the Membership Fines, Fees, and Loan Time Policy.

*Changes to be made to the Ordinance No. 2013-04 (Amended August 2016) is remove the language of having to certify letters and modify the amount/cost of having a library membership for non-residents.*
