PROCLAMATION OF FIREWORKS RESTRICTIONS 2021

WHEREAS, the Anthony Board of Trustees is the governing body of the City of Anthony, New Mexico; and

WHEREAS, the Anthony Board of Trustees has reviewed information published by the National weather service concerning weather condition;

WHEREAS, for best safety interests of the citizens, structures and land within the City limits, certain types of fireworks shall be banned: and

WHEREAS, the City of Anthony asks of all vendors and purchasers to abide by the list published within this proclamation; and

NOW, THEREFORE, be it proclaimed by the Board of Trustees of the City of Anthony, New Mexico:

- 1) That severe drought conditions exist within the City of Anthony.
- 2) THAT within the municipal boundaries of the City of Anthony, the sale and use of the following is prohibited by this Proclamation;
 - a. Aerial spinners
 - b. Helicopters
 - c. Missile type rockets
 - d. Stick-type rockets, other than those having a tube less than five-eighths inch outside diameter and less than three and one-half inches in length.
 - e. Chasers
 - f. Saturn Rockets
- 3) THAT the Board of Trustees is authorized to and has limited the use of any fireworks not listed in Paragraph (2) above to areas within the municipal boundaries of the City of Anthony that are paved or barren or have a readily accessible source of water for use by the homeowner or the general public;
- 4) THAT the Board of Trustees is authorized to and hereby bans the use of all fireworks within wild lands (areas that are covered wholly or in part by timber, brush or native grass) within the City of Anthony; and
- 5) THAT the Board of Trustees is authorized to and has prohibited or restricted the sale or use of display fireworks by permit only; and
- 6) Proclamation shall not prevent the City from authorizing a firework display on its own property which includes fireworks that would otherwise be prohibited by the Proclamation.



This Proclamation shall be effective for a period for thirty (30) days from the date of approval unless a subsequent Proclamation is issued by the Board of Trustees extending, modifying, or rescinding this Proclamation.
