### 6. ITEMS FROM THE FLOOR

<u>Mayor Art Franco</u> – wanted to share information with the Board in regards to a sports family festival the Town of Anthony, Texas is holding in April of this year. (April 19<sup>th</sup> and 20<sup>th</sup>) He wanted to know if we will partner with them and promote the festival on the New Mexico side of the city. Trustee Gonzalez appreciates his efforts to include the city in all of their activities. Mayor Castañeda agreed with Trustee Gonzalez's appreciation and indicated to Mayor Franco the city of Anthony will join efforts with their staff for this event.

Maria Enriquez – Concerned resident of the city wanted to know why Loma Linda does not have any lights yet. Also inquired about policing during the day, where are our police officers during the day? She stated she is the person running the library and she always gets questions from community in regards to all this. She loves this city and if and when the city takes over, things cannot change as we need to walk with firm steps. Also stated Loma Linda crosswalk needs to be repainted. Mayor Castañeda provided feedback in regards to the comments made. He stated that only six months ago was when the city took over 30 street lights, six weeks ago 21 lights were ordered and are now being installed. Within the next six months, the entire city should be lit. As far as P.D. is concerned, the city currently has two police officers, therefore we do not have 24-hour coverage. About the library, as of now, the library does not belong to the city, so anything to do with it is beyond our control. If and when the city takes over the library, then there will be changes. Trustee Gonzalez stated that any items pertaining to the school should be taken to the school board.

<u>Maria Delgadillo</u> – She lives off Adams, wants lights and there is a vacant house off Adams Street. Trustee Scott stated a street light cannot be placed right in front of her house especially if she's close to an intersection because it would appear as favoritism, however, the Board will take her concerns into account when selecting streets for lighting.

Margarita Medrano - She came in to thank the Board for the meetings held to remedy the

problems/fighting at Adams Ballpark. On behalf of the parents and community, she is grateful and thankful.
