9. ITEMS FOR DISCUSSION – from item #6

A. Discussion of property donation by Anthony Water and Sanitation for the Anthony Library. (*Mr. Jose Terrones present from Anthony Water and Sanitation District.*) Trustee Gonzalez stated that the library sits on a large parcel of land and asked what percentage of the parcel would be turned over to the City?

Mr. Terrones responded that the parcel of land is approximately ¾ of an acre and that the parcel is currently not subdivided.

Trustee Madrid asked what was the purpose of Anthony Water keeping the other parcel of land?

Mr. Terrones stated that the remainder of the property is committed to the Anthony Charter school and that the District had applied to the State Board of Finance to be able to lease the property for the next five years to them. He also stated that the Board of finance approved the lease after rejecting it twice with the understanding that AWSD commit to making capital improvements to the parcel such as a playground, pavement etc.

Trustee Scott asked if there are funds available for operating the library?

Mr. Terrones answered "yes" and that utility costs are approximately \$20,000 per year according to Ms. Loren Schoonover.

Trustee Gonzalez said that the City will be eligible for funding after one year of operating the library. She further stated that the library was very small.

Mr. Terrones replied that there is plenty of room to expand.

Trustee Gonzalez asked if there was a possibility of a joint powers agreement for the shared use of the library and playground area.

Mr. Terrones replied that there is a possibility.

Trustee Madrid stated that we might be getting the library but we are also being surrounded by the charter school.

Mayor Castañeda reminded the board that AWSD cannot operate a library as per state statute; however the City can and can also seek funds from the state but only after being self-sufficient for the first year of operation.

Trustee Madrid said that the city is overcrowded with dogs and that is dangerous for kids.

Trustee Scott added that the city needs an animal control ordinance. Trustee Gonzalez asked how much gas was being spent by the police department vehicles and further stated that she would like to see a report with a breakdown of gasoline usage.

Trustee Scott mentioned that the community will eventually lose the Sheriff Department substation and he wanted to know how many calls the city police department respond to and how many calls did the Sheriff's department respond to. (Chief Roybal would research this question.)
