



ORDINANCE NO. 2018-001

AMENDED May 3, 2023

AN ORDINANCE ESTABLISHING A PARK COMMISSION COMMITTEE FOR RECREATION AND BEAUTIFICATION OF PARKS FOR THE CITY OF ANTHONY, NEW MEXICO

WHEREAS, the staff of the Governing Body did duly publish notice of this ordinance in accordance with the law and

WHEREAS, the Governing Body did hold a duly noticed public meeting and did consider testimony from staff and the public before reaching its decision and

WHEREAS pursuant the City of Anthony, NM. announced this ordinance for purpose of establishing a Park Commission for the purpose of:

Section I. NM STAT § 3-47-1 Park Commissioner; appointment; term; qualification; removal; vacancy.

A. PARK COMMISSION

The Governing Body may appoint a Park Commission along with its members for a parks, recreation, and beautification committee.

B. APPOINTMENT

The committee shall consist of three (3) members appointed by the Governing Body.

C. TERMS AND QUALIFICATIONS

1. One commissioner shall serve a one (1) year term; one commissioner shall serve a two (2) year term; and one commissioner shall serve a three (3) year term so that after the initial appointments, one commissioner shall be appointed each year for a three (3) year term without compensation.
2. The City Park Commissioner shall determine by lot their representative terms.
3. The commissioner members of the committee shall be residents of the municipality; unless otherwise approved by the Governing Body; an interested individual shall submit a letter of interest to the City Clerk who will provide copies to the Governing Body for review, appointment, and approval.

D. REMOVAL AND VACANCY

The Governing Body may remove any City Park Commissioner or member for cause and may fill any vacancy on the Park Commission for the balance of the unexpired term.

SECTION II. NM Stat § 3-47-2 Organization of Parks Commission; powers; duties of officers.

- A. The Park Commission committee shall meet within thirty (30) days after the date of the appointment of any new member or members and elect one commissioner as president, one commissioner as secretary, and one city park commissioner.
- B. The Park Commission shall establish and submit a yearly calendar schedule of the date and time of such meetings to the City Clerk to which all meetings will be open to the public pursuant to the Open Meetings Act. The Park Commission shall meet at a minimum of one (1) regular meeting each month.
- C. The Park Commission may receive help with the preparation of the agendas, minutes, and reports by the City Clerk, who shall post the Park Commission agenda 72 hours before a meeting.

The agendas and minutes must contain the following below:

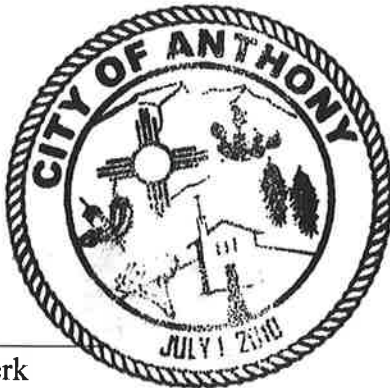
- Park Commission meeting title
- Place of meeting



- Time of meeting
 - Items for discussion
- D. The secretary shall keep a record of activities at meetings (minutes) of the Park Commission. Copies shall be submitted to the City Clerk for record keeping.
- E. The Park Commission shall submit and present to the Governing Body recommendations concerning the management, improvement, and development of parks.
- F. The duties and responsibilities of the Park Commission shall be to act in an advisory capacity to the Governing Body in the following areas:
- The administering of recreational programs and measurements regarding public use of parks.
 - The development of facilities, programs, and improvement of recreational services.
 - The adoption of standards to be upheld in facilities
 - The coordination of city recreation services
 - Holding public meetings and obtaining public input and preparing recreational schedules.
 - The development, promotion, and creation of sponsor programs and activities for the improvement of recreational programs.

NOW THEREFORE, LET IT BE ORDAINED BY THE GOVERNING BODY OF THE CITY OF ANTHONY, NEW MEXICO, THAT THE GOVERNING BODY HEREBY ADOPTS THE FOLLOWING PAR COMMISSION AND THE REGULATION AS STATED ABOVE.
