1. **CALL TO ORDER @ 6:01pm** by *Chairman Herrera*
2. **PLEDGE OF ALLEGIANCE** by *Chairman Herrera*
3. **ROLL CALL.** Present – *Comm. Madrid, Comm. Ramos, Chairman Herrera, Comm. Brumlow, Comm. Gomez*
4. **APPROVAL OF AGENDA ORDER** – *Motion to approve agenda order was made by Comm. Brumlow, 2nd by Comm. Gomez, unanimous vote, motion passed and agenda was approved.*
5. **PUBLIC MEETING:**

Work Session: - *Commissioner Gomez researched neighboring cities and found documentation that would help resolve our issues. Comm. Gomez stated Las Cruces has information on stopping and standing, but it's all under traffic not Planning and Zoning. Comm. Gomez stated the document was very informative and could be revised to add or omit items to fit the city's needs. Chairman Herrera stated he thought this document should be put into resolution form. Comm. Brumlow voiced her concerns stating that she did not believe this to be our job but that of Police Department. She also stated she has seen people around town making make shift streets which are becoming an issue. Comm. Gomez stated he would like to see all alleys made into one way streets. He also stated during his research he came across some land near the restaurant Canastus y Cazuelas showing no one as the owner. Chairman Herrera advised the board he would do some researching on the land as well as the document Comm. Gomez had brought in.*
