- 3. ROLL CALL Absent: Arnie Castañeda Present: Fernando Herrera, Arturo Madrid, Robert Mimbela.
- **4. APPROVAL OF AGENDA ORDER** There was no approval, Commissioner Herrera began with the approval of the minutes.

# 5. APPROVAL OF MINUTES

\*Minutes September 15, 2011

All commissioners discussed minutes before approving, Comm. Herrera read through them. Motion to approve minutes from 09/15/2011 made by Robert Mimbela, 2<sup>nd</sup> by Arturo Madrid, all in favor, motion passed, and minutes were approved.

## 6. PUBLIC MEETING

- A. Case No. 11.09.004 Resident Heliodoro Hinojosa is requesting approval of a variance to move and install mobile home unit on Regan Road, CR-1 Zoning. *Discussion:* Commissioners went over the map, Mr. Hinojosa is in a CR-1 zone (which is community residential), and theoretically no mobile home should be allowed in this zone. A question was made whether the variance (if allowed) would be temporary or permanent, by Tierra del Sol employee in the development department. He was concerned since that area is strictly zoned for homes. Commissioner Mimbela suggested he be granted a variance until they begin developing the land for residential homes to be built. It was then known Mr. Hinojosa is *not* the owner of the property commissioners highly suggest the owner of the land be present at this meeting and it be himself that requests this variance. If variance is not allowed, owner can bring it up to the Board of Trustees. Motion was made by Commissioner Mimbela to table the item until the owner presents himself at the next meeting, 2<sup>nd</sup> by Arturo Madrid, unanimous vote, motion carried. Case No. 11.09.004 was tabled.
- B. Case No. 11.09.005 Resident Guadalupe Saenz is requesting approval of a variance to subdivide her property located at 1400 Church Street, in order to install a mobile unit.

Discussion: Commissioners calculated all the feet (setbacks) for Mrs. Saenz in order to allow for the variance, however, the variance would be very large (about 1600 square feet). Commissioner Madrid stated there are a large number of mobile homes in large lots and the city should shift away from that because if they grant one variance, they have to grant them all. A suggestion made to Mrs. Saenz to bring this up to the Board of Trustees at their next meeting by Commissioner Herrera. Motion was made to deny the variance by Commissioner Madrid, 2<sup>nd</sup> by Robert Mimbela, all in favor, motion carried. Case No. 11.09.005 denied.
