PROCLAMATION

Mayor and Board of Trustees of the City of Anthony, New Mexico
A PROCLAMATION DECLARING APRIL 11–17 2021, AS NATIONAL PUBLIC SAFETY TELECOMMUNICATIONS WEEK

WHEREAS, emergencies can occur at any time that require police, fire, or emergency medical services; and

WHEREAS, when an emergency occurs the prompt response of police officers, firefighters, and paramedics is critical to the protection of life and preservation of property; and

WHEREAS, the safety of our police officer, firefighters and emergency medical personnel is dependent upon the quality and accuracy of information obtained from citizens who telephone the Mesilla Valley Regional Dispatch Authority Communications Center; and

WHEREAS, professional Public Safety Tele communicators are a vital link between citizens and victims and are the first and most critical contact our citizens have with emergency services; and

WHEREAS, Public Safety Tele communicators are the single vital link for our police officers, firefighters, and emergency medical personnel by monitoring their activities by radio, providing them information, and insuring their safety; and

WHEREAS, Public Safety Tele communicators have been recognized as First Responders in Dona Ana County, New Mexico; and

WHEREAS, Public Safety Tele communicators of the Mesilla Valley Regional Dispatch Authority have contributed substantially to the apprehension of criminals, suppression of fires, and treatment of patients; and

WHEREAS, the global Public Health Pandemic has taxed the resources of the public safety communications system requiring the need to adapt to changing conditions and increasing the responsibilities of all Public Safety Tele communicators; and

WHEREAS, each dispatcher has exhibited compassion, understanding, and professionalism during the performance of their job in the past year.

NOW, THEREFORE, IT IS PROCLAIMED by the Governing Board of the City of Anthony that the week of **April 11–17, 2021 to be National Public Safety Telecommunications Week** in Anthony NM, Dona Ana County, in honor of the men and women whose diligence and professionalism keep our City and citizens safe.
