A RESOLUTION ADOPTING CITY OF ANTHONY EMPLOYEES HANDBOOK AMENDMENTS.

WHEREAS, the City utilizes the Employee Handbook (as amended through January 20, 2021) (hereinafter, the "Employee Handbook") for use by its employees and;

WHEREAS, the City Manager has recommended changes to the Employee Handbook;

WHEREAS, proposed changes to the Employee Handbook were discussed and reviewed by City attorney, City clerk, and the Board of Trustees;

NOW THEREFORE, THE BOARD OF TRUSTEES OF THE CITY OF ANTHONY, NEW MEXICO HEREBY RESOLVES:

- 1) That **Section 9:4 Maternity/Paternity leave**, attached hereto as **Appendix A**, is incorporated into the Employee Handbook.
- 2) The effective date of the changes shall be January 19, 2022.
- 3) The City Manager has the authority to interpret the Employee Handbook to effectively and efficiently manage the daily operation of the City.
- 4) The current version of Section 9:4 in the Employee Handbook is hereby repealed and replaced by the language found in Appendix A.

Paid Parental Leave Policy - (Section 9:4 Maternity/Paternity leave)

Purpose/Objective

The City of Anthony will provide up to five weeks of paid parental leave to employees following the birth of an employee's child or the placement of a child with an employee in connection with adoption or foster care. The purpose of paid parental leave is to enable the employee to care for and bond with a newborn or a newly adopted or newly placed child. This policy is intended to compliment and run concurrently with parental leave available under the Family and Medical Leave Act (FMLA). This policy will be in effect for births, adoptions, or placements of foster children occurring on or after [01/19/2022].

Eligibility

To be eligible for paid parental leave, employees must meet the following criteria:

- Have worked at least 12 months (the months need not be continuous) for the City and for at least 1,250 hours during the 12 consecutive months immediately preceding the date the leave would begin.
 - An employee's total hours worked does not include vacation, holidays, sick pay, unpaid leave, or any period of separation from the City.
 - Any period of employment preceding a break in service of seven (7) years or more is not counted toward the one (1) year employment requirements.
- Be a full- or part-time, regular employee (temporary employees and interns are not eligible for this benefit).

Reasons for Parental Leave

Paid parental leave may be taken for the following reasons:

- The birth of a son or daughter of the eligible employee.
 - The term "son or daughter" means a biological, adopted, or foster child, a stepchild, a legal ward, or a child of a person standing *in loco parentis* (i.e. has the day-to-day responsibilities to care for and financially support the child).
- The placement of a son or daughter with the employee for adoption or foster care (in either case, the child must be age 17 or younger).
 - The adoption of a new spouse's child is excluded from this policy.

Amount, Time Frame, and Duration of Paid Parental Leave

- Eligible employees will receive a maximum of 2 weeks of paid parental leave per birth, adoption or placement of a child/children. The fact that multiple births, adoptions, or placements occur (e.g., the birth of twins or adoption of siblings) does not increase the five-week total amount of paid parental leave granted for that event. In addition, in no case will an employee receive more than five weeks of paid parental leave in a rolling 12-month period, regardless of whether more than one birth, adoption, or foster care placement event occurs within that 12-month time frame.
- Each week of paid parental leave is compensated at 100 percent of the employee's regular, straight-time weekly pay. Paid parental leave will be paid on regularly scheduled pay dates.
- Approved paid parental leave may be taken at any time during the twelve (12) month period immediately following the birth, adoption, or placement of a child with the employee.
- Employees must take paid parental leave in one continuous period of leave and must use all paid parental leave during the time frame indicated above.
- Upon termination of the individual's employment at the City, he or she will not be paid for any unused paid parental leave for which he or she was eligible.

Coordination with Other Policies

- Paid parental leave taken under this policy will run concurrently with leave under FMLA; thus, any leave taken under this policy that falls under the definition of circumstances qualifying for leave due to the birth or placement of a child due to adoption or foster care, the leave will be counted toward the 12 weeks of available FMLA leave per a 12-month period. All other requirements and provisions under the FMLA will apply. In no case will the total amount of leave—whether paid or unpaid—granted to the employee under the FMLA exceed 12 weeks during the 12-month FMLA period. Please refer to the Family and Medical Leave for further guidance on the FMLA.
- After the paid parental leave is exhausted, the balance of requested leave will be compensated through employees accrued sick, and vacation time. Upon exhaustion of accrued sick, and vacation time, any remaining leave available under FMLA will be unpaid leave. Please refer to the Family and Medical Leave Policy for further guidance on the FMLA.

- If a company holiday occurs while the employee is on paid parental leave, such day will be charged to holiday pay; however, such holiday pay will not extend the total paid parental leave entitlement.
- If the employee is on paid parental leave when the company offers administrative leave (known as an "admin pay"), that time will be recorded as paid parental leave. Administrative leave/pay will not extend the paid parental leave entitlement.
- An employee who takes paid parental leave will be afforded the same level of job protection for the period of time that the employee is on paid parental leave as if the employee was on FMLA-qualifying leave.

Requests for Paid Parental Leave

- The employee will provide his or her supervisor and the human resource department with a notice of the request for leave at least 30 days prior to the proposed date of the leave (or if the leave was not foreseeable, as soon as possible). The employee requesting FMLA should complete Forms 381 and provide all documentation as required by the HR department to substantiate the request.
- As is the case with all city policies, the organization has the exclusive right to interpret this policy.

SECTION III – NOTICE OF RIGHTS AND RESPONSIBILITIES

Part A: FMLA Leave Entitlement

You have a right under the FMLA to take unpaid, job-protected FMLA leave in a 12-month period for certain family and medical reasons, including up to 12 weeks of unpaid leave in a 12-month period for the birth of a child or placement of a child for adoption or foster care, for leave related to your own or a family member's serious health condition, or for certain qualifying exigencies related to the deployment of a military member to covered active duty. You also have a right

under the FMLA to take up to **26 weeks** of unpaid, job-protected FMLA leave in a single 12-month period to care for a covered servicemember with a serious injury or illness (*Military Caregiver Leave*).

The 12-month period for FMLA leave is calculated as: (Select as appropriate)

- \Box The calendar year (January 1st December 31st)

Part B: Substitution of Paid Leave – When Paid Leave is Used at the Same Time as FMLA Leave

You have a right under the FMLA to request that your accrued paid leave be substituted for your FMLA leave. This means that you can request that your accrued paid leave run concurrently with some or all of your unpaid FMLA leave, provided you meet any applicable requirements of our leave policy. Concurrent leave use means the absence will count against both the designated paid leave and unpaid FMLA leave at the same time. If you do not meet the requirements for taking paid leave, you remain entitled to take available unpaid FMLA leave in the applicable 12-month period. Even if you do not request it, the FMLA allows us to require you to use your available sick, vacation, or other paid leave during your FMLA absence.

Part C: Maintain Health Benefits

Your health benefits must be maintained during any period of FMLA leave under the same conditions as if you continued to work. During any paid portion of FMLA leave, your share of any premiums will be paid by the method normally used during any paid leave. During any unpaid portion of FMLA leave, you must continue to make any normal contributions to the cost of the health insurance premiums. To make arrangements to continue to make your share of the premium payments on your health insurance while you are on any unpaid FMLA leave, contact ______ at

You have a minimum grace period of (\Box 30-days or \Box *indicate longer period, if applicable)* in which to make premium payments. If payment is not made timely, your group health insurance may be cancelled, provided we notify you in writing at least 15 days before the date that your health coverage will lapse, or, at our option, we may pay your share of the premiums during FMLA leave, and recover these payments from you upon your return to work.

You may be required to reimburse us for our share of health insurance premiums paid on your behalf during your FMLA leave if you do not return to work following **unpaid** FMLA leave for a reason other than: the continuation, recurrence, or onset of your or your family member's serious health condition which would entitle you to FMLA leave; or the continuation, recurrence, or onset of a covered servicemember's serious injury or illness which would entitle you to FMLA leave; or other circumstances beyond your control.

Part E: Return-to-Work Requirements

You must be reinstated to the same or an equivalent job with the same pay, benefits, and terms and conditions of employment on your return from FMLA-protected leave. An equivalent position is one that is virtually identical to your former position in terms of pay, benefits, and working conditions. At the end of your FMLA leave, all benefits must also be resumed in the same manner and at the same level provided when the leave began. You do not have return-to-work rights under the FMLA if you need leave beyond the amount of FMLA leave you have available to use.

Part F: Other Requirements While on FMLA Leave

If the circumstances of your leave change and you are able to return to work earlier than expected, you will be required to notify us at least two workdays prior to the date you intend to report for work.
