9. ITEMS FROM THE MAYOR AND TRUSTEES

Trustee Herrera: NONE

Trustee Garcia: Requested from the City Manager to investigate annexation property east of I-10 and north of O'hara for the relocation of the Solid Waste Station. He reiterated that he was not opposed to the project itself but with the current location. As an advocate for the city's youth, his focus during his term is to prioritize the youth and bring facilities and programs to the City. Requested to reschedule the workshop on Monday, January 22 at 6:00pm to discuss all items that have been postponed.

MPT Holguin: Echoed Trustee Garcia's plans for annexation, would like administration to educate the Board on annexation and move to relocate that facility away from Dos Lagos. He would like to leave the Dos Lagos development for entertainment. He requested resolution 2023-041 "Colonias Infrastructure Loan/Grant Agreement for the Solid Waste Transfer Station of \$800,000..." back to the Board to rediscuss or rescind the vote and would like an annexation presentation for the next meeting. After clarification from the City Manager stating that the current funding does is not tied to the physical location of this project, no poll was taken for these items to be added to the next agenda. The City Manager assured that he will be presenting on annexation at the upcoming workshop. Lastly, requested that with the removal of the previous MPT, he requested he be added to the list of City signatories to comply with the newly amended Finance Policies and Procedures.
