b. Consideration and Action to submit for the FY 2024/2025 Local Government Road Fund Municipal Arterial Pavement (MAP) Funding Application for Church Street Phase II, Presented by City Manager.

City Manager reiterated the application criteria, that was discussed in the previous Workshop. This program is funded by the Local Government Road Fund for Phase II of Church Street, which is from Clark to Ruth. As a reminder this project has been phased out into three parts. He informed the Board that the City did not have any MAP funding so he is confident that this project can be selected for funding. The Board might notice that this phase of the project is also being proposed for TPF funding, City Manager suggests applying for \$500,000 for the MAP application and \$1.5 million under the TPF. He suggests these numbers for each respected application because the MAP requires a 25% match while the TPF requires only 5%. Current projections for Phase II are \$3 million, he wanted to make sure the Board was aware that additional funding will be needed to complete Church Street.



**Trustee Garcia:** Questioned City Manager how long it would take to develop 100 acres east of Dos Lagos, the City Manager asked for further clarification because the City currently does not have 100 acres east of Dos Lagos. The City Manager further explained that we would have to obtain funding to acquire the land first, once acquired it would depend on what is being developed there. If there were funds to purchase the land, design, and planning, it could take up to 18 months to develop. Has some hesitation with fulfilling Tierra del Sol wishes for a new development in Dos Lagos since the current developments do not have enough parks. Would like to have the Master Plan updated as it has been years. Requested an organizational chart for all employees. Requested items such as the Employee Handbook, Finance Policies and Procedure, Vehicle Use Policy, and Substance Use Policy. Requested bank statement register, the City Manager informed that this is something that the Finance Director does keep track of and is sent out monthly already. Asked the City Manager to investigate providing gas to residents that are not currently hooked up. Suggested having a clean-up for the City with volunteers and city staff to regain the trust of the residents. **MPT Holguin:** Crosswalk repainting at the intersection of 4th Street and Landers. Wanted to inform the public about the discussion that occurred during Closed Session, unfortunately the meeting was adjourned
