a. Presentation on the New Mexico Department of Finance and Administration's Trainings and

#### Assessments, Presented by Trustee Jose Garcia.

**a.** Consideration and Action to approve Morrow Enterprises proposal for the Duffer Lane Phase 3 Multi Use Trail, *Presented by the Projects Coordinator*.

This proposal is for the construction of the Duffer Lane Phase Multi Use Trail that was awarded to the City's On-Call Contractor, Morrow Enterprises for a total of \$392,088.28. Trustee Herrera wanted to inform the public that this project is to complete the Multi Use Trail as the design was completed last year. MPT Holguin would like in the future to put more projects out to bid as opposed to awarding them to the On-Call to allow more diverse work and business within the City. Trustee Herrera asked for some clarification on going out to bid versus awarding to an on-call, highlighted the pros and cons, one being that awards to on-calls save time and money.

MPT Holguin read what is considered confidential information under state law and what can and cannot be disclosed to the public that occurred during closed session. He wanted to inform the public about the misuse of city funds, he strongly believes that the Mayor should not be getting the attorneys she is utilizing for this specific lawsuit paid for, since he is paying for his own. At the very least this request for payment should have come to the board for approval. Nearly \$24,000 has been utilized for this lawsuit to have MPT Holguin removed, this came after public comments were removed and he started to advocate for the residents and calling the attention to the State auditors and the Attorney General. He expresses that these funds could be used to streets but are being misused to pay for the wrong thing.

e. Consideration and Action to approve the hiring of a Temporary IT, Presented by HR. The HR Director informed the Board that prior to the hiring freeze that was approved the 17th of January, she had filled all open positions except for the Police Department but the candidate for the IT Assistant position was unable to move forward after the background check. There has been a struggle without an IT assistant and is concerned that moving forward with a "temporary" IT would lessen the number of candidates. Trustee Garcia questioned if there is no IT Manager how we are jumping straight into hiring an IT Assistant, the HR Director explained that the City did that to lower the expense of that department (a higher position would require higher pay) and the City utilizes Spectrum as a third-party vendor for IT issues. It would be more beneficial to have an in-house IT Assistant that can streamline communication between the City's needs and Spectrum. Trustee Garcia asked what the Spectrum contract consists of, which includes things such as equipment breaking down, a help desk and support the firewall protection. Trustee Garcia further questioned in the situation that recently occurred where a meeting had to be cancelled because of IT issues, why Spectrum could not help. The HR Director explained that another issues with only having Spectrum is that they are 8am-5pm. Because of this Trustee Garcia suggested that he would like the City to move forward with hiring a temporary IT with the probability of a full-time position based on their performance and terminate the contract with Spectrum. The HR Director advised against that since even with full-time IT personnel, Spectrum would still need to oversee important aspects of City's infrastructure. City Manager recommended Spectrum present in a future meeting to inform the

public about their services but if it is the Board's desire to advertise as temporary and get to the Board with the number of candidates. If the board is to move forward with this a new job description and pay rate would need to be considered as it doesn't currently exist. MPT Holquin would like to
