7. ITEMS FROM THE MAYOR AND TRUSTEES

Trustee Barreras: Advised other Board members of complaints received on the property on Church and Ruth St. **Trustee Garcia:** Notified the Mayor of several non-functioning lights along the Walking Path and requested action on a cracked sidewalk on Acosta Street that has remained unaddressed for several months. He also requested an update on the sale of the City vehicle. A lengthy discussion followed regarding the vehicle's status. The HR Director informed the Board that the sale process was in progress, but noted concerns regarding ADA accommodation, prompting her to seek external legal counsel. MPT Holguin clarified that the concern involved reimbursement for personal use, and reiterated the Board's May 29, 2025 directive to proceed with the sale and file a writ of mandamus should the Mayor fail to relinquish the vehicle keys. MPT Holguin expressed concern over the lack of communication to the Board and raised issues with the HR Director's failure to follow multiple directives, including the vehicle sale, posting of the in-house counsel position, and issuance of a check to Attorney Yvonne Quintana. He concluded by insisting the writ of mandamus be filed by Friday morning.

Trustee Herrera: Trustee Herrera stated that his decision to support the sale of the City vehicle was based on guidance received from the President of the New Mexico Municipal League, who confirmed there is no state statute requiring municipalities to provide an ADA-designated vehicle. In the absence of a City ordinance or resolution mandating such accommodation, he affirmed that the sale is valid. Additionally, Trustee Herrera referenced a deteriorating building in the downtown area, noting that under state statute, the City has the authority to act through due process. He suggested that the City act within its legal authority in addressing the matter.

8. PRESENTATION

a. Presentation of the 2024 Audit Report, Presented by Beasley, Mitchell & Co.

Mr. Juan Garcia, Audit Manager for Beasley, Mitchell & Co., began his presentation by expressing appreciation to City management for their cooperation during the audit process. Mr. Garcia informed the Board that the firm issued an unmodified opinion, this indicates that the financial statements are presented fairly, in all material respects, and without reservation. He noted that, as of the fiscal year 2023, there were a total of seven audit findings. Of those, four have been resolved. The three remaining findings, which are repeated from previous audits, include: Design Deficiencies in Internal Control (2019), Cash Reconciliation (2019), Interim City Manager Position (2023), where the vacancy was not addressed in the subsequent meeting as required. Mr. Garcia concluded by emphasizing that 2024 had the fewest audit findings to date and that no new findings were identified in this audit cycle.

9. DISCUSSION

a. Discussion on the deployment of three (3) remaining pole mounted graphic displays for speed, **Presented by Chief Ordonez and Lt. Guerrero.**

The Chief of Police requested input from the Board and the community regarding the placement of three speed graphic displays intended to deter speeding and increase driver awareness. MPT Holguin, Trustee Garcia and Mayor Murillo suggested along Church St. The Chief encouraged Board members to share any additional suggestions with the Mayor so that they may be compiled and brought before the Board for formal consideration and action.

b. Consideration and Action to approve Tyler Technologies Mobile/Field Reporting services procured through CES, *Presented by the Chief of Police*.

The Chief of Police informed the Board that the quote presented at the meeting differs from the one previously provided due to the removal of a feature the department is not yet prepared to implement. The updated quote reflects an initial cost of \$50,880, with a recurring annual fee of \$2,457. She stated her intent to proceed with the purchase before the end of the fiscal year on June 30th. The Chief plans to utilize the remaining \$32,000 from the Law Enforcement Protection Fund to partially cover the initial cost, with the remaining balance to be paid from the department's budget. This procurement was conducted through a Sole Source Agreement via CES.

c. Consideration and Action to approve the set up of a single entity network infrastructure for the Police Department, *Presented by the IT Assistant*.

The IT Assistant requested Board approval to separate the Police Department's network from the City's system to improve cybersecurity and connectivity. Two proposals were presented: one from Spectrum at \$473.67/month and another from Conterra, which includes fiber optic installation, a one-time cost of \$1,171, and \$437/month. The City would need to provide its own server. The IT Assistant recommended Conterra for its long-term benefits, including potential future fiber expansion to other City facilities and businesses. The majority of Trustees supported the recommendation
